

## Booking conditions and rental Aqua Home by - Ref :Biesbosch Adventures C.V. - Version: 2017

1. **Reservation.** After registration, the tenant will be mailed a contract for signature. The final booking will be made upon receipt of the original, by the tenant signed agreement, copy of passport or driving license and deposit. The signed agreement may also be mailed as a photo or scan. The deposit must be received within 2 days of agreement submitted. After that time, we cannot guarantee availability. no booking fee per booking will be charged. After receiving the payment you will receive approximately two weeks before the travel voucher with travel documents. In case of excess of payment Aqua Home will get in touch with you. Failing payment, the booking will be canceled and the cancellation costs as described below, plus any collection costs are passed on to you.

Payment terms remainder:

The payment of the balance to be paid after receipt of invoice within 2 days.

- 2. **Deposit**: Aqua is home to the tenant made available after payment of a deposit. Payment can be made by bank transfer. The amount of the deposit is equal to the excess. If the injury appears to be higher, the tenant paid the remaining amount. Aqua Home is assured WA offered. After leaving the Aqua Home by the tenant the deposit, after deducting any damage to the Aqua Home and / or equipment, be refunded by bank transfer to the tenant.
- 3. **Cancellation:** Aqua Home rentals up to 2 weeks before departure: 50% of the total amount within 2 weeks before departure: 100% of the total
- 4. **Liability:** We accept no liability reasonable way resulting from small differences in given year, dimensions and / or equipment.

Aqua Home does not accept any liability for loss, theft, damage or injury occurring during the travel and rental period

- 5. **Acceptance:** Aqua Home will be cleaned with a complete inventory and are offered in a good state of repair. Upon termination of the tenancy, the tenant will transfer the Aqua Home to the landlord in the same condition as when it was received.
- 6. **Liability at booking:** The signer of the lease also booked for the other participants and is jointly and severally liable for all participants will be notified. Renter must be at least 21 years. A copy of the passport of the person signing must be attached to the signed contract.
- 7. **Complaints:** It is important to check the Aqua Home after embarkation (departure) carefully for defects or missing inventory. In case of complaints should be reported to the departure to the landlord. This will make every effort to resolve any problems. If no satisfactory solution can be obtained, please notify us in writing within 21 days after returning home. Complaints about the contents of the inventory after departure will not be accepted.
- 8. **Rental Period:** In case of exceeding the agreed rental period may charge the landlord for this extra cost, which is commensurate with the prevailing rate.
- 9. **Times on / sailing into**: During the check-in procedure, the landlord will arrange a day and time that you will be pleased with the Aqua Home.
- 10.**Sailing:** Possibly go on with our captain to another location can normally only at the earliest on the second day of your rental period. The cost of hiring a skipper a € 60, including VAT per hour and will be charged after the rental period. These costs are paid within 8 days. Usually no later than the afternoon prior to the last day of your rental period Aqua Home again is in the home.

Out on the earlier date / time stated on your contract should be done in consultation.

- 11. **Routes / programs:** Suggested routes and programs can at all times, in concert, to be adjusted if circumstances so require. On given routes / neither programs no rights can be derived from nor give exceptions entitled to a refund or other compensation.
